

## Subject: Seeking partnership with leading industry player for financial and technical support in upgradation for 20 Govt. ITIs in Uttarakhand

The Department of Skill Development and Employment (DSDE), Govt. of Uttarakhand humbly invites leading industrial players to submit their interests in providing technical and financial support in overall upgradation of 20 GITIs (Govt. ITIs) in Uttarakhand.

### **Background**

The ITIs has been the backbone of industrial growth in India and shall be the flagbearers of the realization of dream to make ourselves “Atmanirbhar”. In order to make India a 5 trillion economy, India needs 22 million skilled people, and ITIs need to be well equipped to provide skilled workforce to the industry 4.0 requirements.

The Directorate of Training under DSDE, Govt. of Uttarakhand is running 91 ITIs which are providing DGT affiliated and NCVT aligned technical vocational training to the youth of Uttarakhand. Approximately 4000 candidates pass out of these state Government ITIs every year to join the skilled workforce of the country.

The upgradation of the State ITIs has been envisioned across the following areas:

#### **1. Infrastructural Upgradation**

- Civil Renovation and Electrical power supply Upgradation Works
- Creation of CoEs (Centers of Excellence) and Advanced Technology Hubs
- Technical Workshop Infrastructure
- IT Infrastructure Development
- Other items including furniture, power backup, solar power installation etc.

#### **2. Soft Upgradation**

- Introduction of Long-term demand-oriented trades
- Introduction of Short-term demand-oriented trades
- Trade Rationalization
- Industry 4.0 Aligned Curriculum Development
- Employability Skills Development
- Professional Training of ITI Staff
- Deployment of Subject Matter Experts from Industry
- Industry Linkages for OJT, Apprenticeships
- Partnering with MSMEs for transforming ITIs into Production Hubs
- e-Learning Platform for staff/students
- Training Certifications from leading Industries

The industry partner is free to propose other upgradation areas which are deemed essential for the enhancing the relevance of GITIs of Uttarakhand from the industry perspective.

### **Expected Outcomes**

- Industry 4.0 aligned technical infrastructure at target ITIs
- Best in class training delivery to beneficiaries through in-house staff and subject matter experts in a sustainable manner
- Increased involvement of industries in training programs, production activities and placements
- Increased job opportunities for ITI trainees in the industry catering to its advanced technology needs

## **Number of ITIs in scope**

Out of the total 91 State GITIs, 24 GITIs have already been taken up for upgradation under the Uttarakhand Workforce Development Project (UKWDP), and remaining GITIs are in scope for upgradation by the potential partner sought. But, the proposal seeks the coverage of about 20 ITIS out of remaining.

## **Key Considerations in the proposal**

- All private/public players are humbly invited to submit their proposal for the above-mentioned scope. The interested players are requested to specify their organization background, capacity and past experience while showcasing their intent for partnership with the State Govt.
- The interested players need to submit a brief upgradation strategic plan which they propose to implement in the 20 target ITIs along with estimated financial implication and timelines.
- The interested players are requested to clearly specify their financial contribution (along with source of funding e.g., CSR, others etc.) across the upgradation areas mentioned by them in the plan.
- The interested players are requested to also specify their expectations from the State Govt. in the proposed partnership
