**Expression of Interest:**

1. Uttarakhand Workforce Development Project, Government of Uttarakhand has been established with development objective of improving the quality and relevance of training at Industrial Training Institutes (ITIs) and to increase the number of labour-market-relevant highly skilled workers through various interventions.
2. As a part of the project, The Department of Skill development and Employment (DSDE) **proposes to enter into partnership agreement with industry leaders to establish a Centre of Excellence (CoE) for Apparel & Textile Sector** in our GITI – Dehradun (Women) campus with the overall objective of enhancing the skill levels of Uttarakhand manpower and trainers ultimately resulting in better placement outcomes for ITI passouts and other skill development trainees.
3. **The potential applicants are envisaged to be industry leaders meeting the following minimum requirements** of 10 years existence in India, INR 250 Cr average turnover over last 3 years, experience in setup of CoE / Skill training institute in apparel / textile and prior experience of working with government in the space of vocational education / skill development in the field of Apparel & Textile sector.
4. The industry leader in partnership with the department shall work for the benefit and development of entire GITI and Skill development ecosystem in Apparel & Textile sector. The industry leader is envisaged to setup an advanced training centre undertaking skill development programs in Fashion designing / technology, Tailoring, advanced sewing machine operations etc.
5. As a part of partnership, industry leader is also expected to participate and contribute in establishing a platform for multi-optional livelihood opportunities (including jobs, self-employment and entrepreneurial activities) for the trainees passing out apart from the industry / market linkage activities, ToT for GITI instructors, participation in mobilization and counselling of suitable trainees and other pre and post training activities.
